Assessment Guidance:

2.1 List of websites can be provided, including organisation's own website, or trusted national/regional websites such as BBC News.

2.3 A user persona with specific needs can be provided indicating the need for using the browser accessibility settings (such as high contrast, text scaling, and audio support).

3.1 & 3.2 Assessment could include narrowing the searching terms and could include the use of:

- Explicit phrasing
- Exclusion of words
- Words in a title
- Specified file types

4.1 A minimum of three different ways should be listed.

4.2 Online file sharing tool to be used. The use of an email attachment would be 'sending' and not 'sharing.'

4.4 Examples of purposes could include:

- Educational purposes
- Business scenarios
- Social media
- Blogging
